## **CONCLUSION SUMMARY**

Section for Child Care Regulation has determined that Panda Care Day Care violated these licensing rules. This determination is based on a Sanitation Inspection that was conducted on August 4, 2020 that reads that the home smelled of pet urine and feces and there was clutter throughout the house. This is also based on interviews conducted by CCFS Zeigenbein on July 28, 2020 where Toni Anderson, Owner stated that the dogs will pee or poop in the house if they are not let outside and based on a statement made by Child A that the dogs pee and poop in the house and Assistant Cindy Boatright's statement that the dogs rarely pee and poop in the house, indicating that they sometime do.

Furthermore, this is also based on CCFS Zeigenbein's inspection on August 12, 2020 when CCFS Zeigenbein noticed a strong odor that was coming from the basement.
