Birth Through Two (2) Years. Groups composed of mixed ages through two (2)- years shall have no less than one (1) adult to four (4) children, with no more than eight (8) children in a group.

### **CONCLUSION SUMMARY**

Section for Child Care Regulation determined that Lee's Kinder Academy violated this licensing rule based on statements made by facility director Shari Lee and caregiver Liliana Lepe. Ms. Lepe stated that she has had 7 toddlers to herself all day at times. Director Sheri Lee stated that caregiver Liliana Lepe probably did have 7 children to herself but only for short periods of time in the morning before all staff arrive. Director Sheri Lee further stated that she believed this to be okay as she thought there was a licensing rule that allowed them to be out of compliance with staff/child ratios for up to 15 minutes.

On January 2, 2020 Child Care Facility Specialist Jana Barton conducted an unannounced inspection at the center and found all classes to be in compliance with staff/child ratios. Staff and children's attendance records were reviewed with Director Sheri Lee and they did not show that the center was out of compliance with staff/child ratios on November 18 and November 19, 2019.

Based on staff interviews, this complaint is substantiated.
