The notice of parental responsibility shall include the following: The staff/child ratios for enrolled children under two years of age, for children ages two to four and for those five years of age and older as required by the department of health and senior services regulations in licensed facilities, the standard ratio of staff to number of children for each age level maintained in the exempt facility, and the total number of children to be enrolled by the facility.

## **CONCLUSION SUMMARY**

CCFs Spaulding conducted an investigation at the facility and found the following violation:

RSMo 210.254.2(3): The notice of parental responsibility shall include the following: The staff/child ratios for enrolled children under two years of age, for children ages two to four and for those five years of age and older as required by the department of health and senior services regulations in licensed facilities, the standard ratio of staff to number of children for each age level maintained in the exempt facility, and the total number of children to be enrolled by the facility.

On May 23, 2019, CCFS Spaulding observed 13 infant toddler children with 2 caregivers. While the Notice of Parental Responsibility states the facility's ratio to be 1 caregiver to every 5 children, the facility was not in ratio at the time of inspection. Caregiver, Carmelita stated when interviewed that the 3rd caregiver, Jarnelle Glasper stepped out of the classroom to use the bathroom.
