19 CSR 30-61.085 (2)(B)(1)

At least thirty-five (35) square feet of usable floor space shall be provided for each child coming into the home for day care.

#### **CONCLUSION SUMMARY**

Based on the investigation, the allegation that on December 14, 2016, at 2:30pm, thirteen children were observed in care, is substantiated.

On January 24, 2017, CCFS Chrisco reviewed the physical plant diagrams and calculations in SCCR's files for Jackie Robinson dba Constantly Growing Home Daycare. The only approved space in Ms. Robinson's home is in the basement level and due to square footage limitations, the space is only approved to care for a maximum of ten children, regardless of their relation to Ms. Robinson.

On February 2, 2017, child care provider Jackie Robinson stated that a social service worker did come to her home on December 14, 2016 to complete an audit and she did have more than ten children in care, in the basement, during that inspection.

On March 23, 2017, Social Service Worker Beverly Bosman stated that she conducted a compliance visit at the home of Jackie Robinson on December 14, 2016. During the visit, she observed thirteen children, ages infants to school-agers, with Ms. Robinson and another teacher. All of the children were in the basement.

The provider shall ensure that the capacity and square footage requirements are adhered to at all times.
