Birth Through Two (2) Years. Groups composed of mixed ages through two (2)- years shall have no less than one (1) adult to four (4) children, with no more than eight (8) children in a group.

## CONCLUSION SUMMARY

It has been determined that Emmanuel Family and Child Development Center and Emergency Shelter for Children violated licensing rules. Staff interviewed reported being out of staff/child ratio at different times and in different rooms. When CCFS Beem conducted an unannounced inspection, the Zippy Zebra room was out of ratio. The room had one staff and six infants. CCFS Beem reviewed the video on the date it was reported there were ratio violations. On September 12, 2019 at 8:38 AM staff/child ratios were two adults with nine children, at 9:18 AM staff/child ratios were one adult with six children and at 9:45 AM staff/child ratios were two adults with nine children in the Zippy Zebra room (an infant/toddler room). On September 12 at 8:35 AM staff/child ratios were one adult with six children and at 9:13 AM staff/child ratios were one adult with eight children in the Little Angel's room (an infant/toddler room). Required staff/child ratios in an infant/toddler unit, by rule, are one staff with four children at all times. Therefore the allegation is substantiated.
