**CONCLUSION SUMMARY**

Section for Child Care Regulation determined this complaint is substantiated. On June 16, 2018 a Special Request Sanitation inspection was completed and pest harborage was found. The facility did not pass their Special Sanitation Inspection.

On June 19, 2018 a Special Request Sanitation re-inspection was completed and the facility passed the re-inspection.

Child Care Facility Specialist (CCFS) Shari Copeland interviewed Board Secretary Alecia Jones both on June 18, 2018 and on June 21, 2018. On June 18, 2018 Alecia Jones indicated that the facility had experienced roaches in the past and that they had not passed a recent Special Request Sanitation Inspection. On June 21, 2018 Board Secretary Alecia Jones indicated that a Special Request Sanitation Re-Inspection was completed on June 19th and the facility passed. Board Secretary Alecia Jones indicated that the facility had been sprayed for roaches after not passing the Special Request Sanitation Inspection. This complaint is being substantiated based on interviews with the Board Secretary Alecia Jones as well as an unapproved Special Request Sanitation Inspection not being passed on June 15, 2018 due to pest harborage.
