CONCLUSION SUMMARY

The Section for Child Care Regulation (SCCR) determined the allegation to be substantiated based on observations from Child Care Facility Specialist (CCFS) Billie Russell. On July 23, 2019, CCFS Russell observed chemicals on food preparation surfaces. Clean and dirty dishes stored together. A laptop computer was on top of the clean dishes on the drying racks. Breakfast dishes left in the sink and on the countertop and breakfast food in a bucket under the sink. A package of frozen food on the countertop. Food packages left open. Papers were over the food preparation surfaces. The kitchen floor was observed to have a brown sticky substance covering it. Sanitation Inspection Reports conducted by Environmental Public health Specialist (EPHS) IV Edith Todd on June 6, 2019, and July 31, 2019 showed the facility did not conform with the sanitation requirements. Lorie Lough, owner, and Lindsey Thorson, caregiver, reported there was no cleaning schedule, however, dishes are done after every meal and a deep cleaning at night.
