Caregivers shall provide frequent, direct contact so children are not left unobserved on the premises.

CONCLUSION SUMMARY

SCCR has determined that the facility was in violation of the above rule based on the security footage and interviews with staff at the center. Staff stated that a parent informed them of a child in the classroom alone. Staff also stated that they found Child A in a classroom and the teachers in charge of Child A were not aware she was not with them when they left to go to another classroom. Both classroom teachers confirm through interviews with SCCR that they left classroom D and went to classroom E leaving Child A in the restroom which was located inside the classroom. Security camera footage confirms that Child A was alone in classroom D from 8:35 a.m. to 8:42 a.m.
