### CONCLUSION SUMMARY

The Section for Child Care Regulations determined the facility violated licensing rules based on interviews with the facility director, Rachel Strange, Caregivers Porsha Battle, Elonda Blanchard, Eternity Edwards, The Mother of Child A, and observations made by CCFS Ray-Warnke. The Mother of Child A stated that the Director, Rachel Strange did orientation, and potty training was discussed. The Mother of Child A received a call at 3:00pm on October 14, 2019. Child A's teacher Miss Elonda Blanchard stated that Child A had pooped in his pants. The Mother of Child A brought in a sleeve of diapers and discussed potty training with Child A's teacher Miss Elonda Blanchard. Caregiver Elonda Blanchard stated that the first day that Child A attended school, she did not know that Child A was in pull-ups. The Director Rachel Strange did not mention that Child A was not potty trained. Miss Elonda Blanchard stated that she only realized that Child A was not potty trained when Child A pooped in his pants at the end of the day. Miss Elonda Blanchard stated that she was supposed to get information in regards to Child A, but did not get any. The assistant caregiver Porsha Battle stated that no one ever told her any information in regards to Child A on October 14, 2019. Porsha Battle stated that she did not know that Child A was working on potty training. Miss Elonda Blancahrd stated that the process of communication and meetings is not consistent. On October 16, 2019 The Mother of Child A stated that when Child A arrived at home his pull-up was full of urine to the point where it was soaking through his pants. The Mother of Child A talked to the assistant teacher, Miss Porsha Battle on October 17, 2019 to let Miss Porsha know that Child A had come home with a diaper that was soaked. Miss Porsha battle did not offer to do anything about it at the time. The Mother of Child A stated that she had never been given a classroom schedule at orientation. The Mother of Child A stated that she had never seen a class schedule posted in Child A's classroom. Caregiver Eternity Edwards stated that in classroom one there is no daily schedule of when diapers should be done. Miss Eternity Edwards stated that she does not have to write down anywhere that diapers are checked. Child A's teacher, Miss Elonda Blanchard stated there is a classroom schedule in classroom two, but there are no bathroom breaks, handwashing, or diaper changing scheduled. Caregiver, Miss Porsha Battle stated that there is no class schedule posted in the classroom that tells when children are supposed to go to the bathroom. Miss Posha Battle stated that the only time she makes sure that children go to the bathroom is before nap. CCFS Ray-Warnke observed the daily schedule of classroom two, and the schedule did not have bathroom breaks, diaper changing or handwashing times indicated. On October 21, 2019 The Mother of Child A picked up Child A from school at 4:00pm. Child A's pants were soaking wet down both pants legs. Child A's socks and shoes were soaked. The Mother of Child A also stated that Child A's diaper was falling apart, and the gel of the diaper fell out of the diaper and onto the floor of her home. Miss Porsha Battle stated

that she noticed that Child As clothes were wet, while Child A was outside on the playground. Miss Porsha stated that she went inside and checked to see if Child A had extra clothes. Child A did not have extra clothes. Miss Porsha Battle stated that it was shortly after she noticed that Child A did not have extra clothes, that the Mother of Child A picked up her child. Child A was never changed out of his wet clothes.

The Director Rachel Strange viewed the video footage of the facility from October 18, 2019. The Director Rachel Strange witnessed Child A take a nap from 1:00pm until 3:26pm. The Director Rachel Strange did not witness Child A's diaper being changed after he woke up from nap from the video footage. Child A was viewed by the Director Rachel Strange as waking up from nap and going immediately to the snack table. The Director Rachel Strange did not see any teachers check Child A's diaper. The Director Rachel Strange did not see Child A go to the bathroom. After Child A had snack the Director Rachel Strange confirmed by video footage that Child A had not been changed after 1:00pm. After reviewing the camera footage the Director Rachel Strange immediately alerted Central Office and let them know of the evidence discovered.
