**CONCLUSION SUMMARY**

Compliance Inspector (CI) Jessica Graham investigated the allegation that Child A (2-years-old) came home several days with dry poop on him and Ms. Kendra was allowing an 8-year-old child change the children. The allegation is substantiated based on the following information:

5 CSR 25-500.182(1)(E)1. which states: "Disposable tissues or wipes shall be used to cleanse the child at each time of diapering. Any diapering creams, powders, or other products applied at the time of diapering shall be provided by the parent(s) and labeled with the child's name."

On August 25, 2022, director Christina Paisley stated that she viewed camera footage of Child A's classroom after hearing from Parent A that he had come home with dried poop on him. Ms. Kendra worked in Child A's classroom and was letting an 8-year-old child change diapers and Child A was one of them. She was not aware that Ms. Kendra did this until she viewed the camera footage. This was most likely the cause of Child A coming home with dried poop on him because he was not cleaned thoroughly.

On August 25, 2022, caregiver Rachel Boatman stated that she viewed video footage and observed Ms. Kendra allowing a child in the room to change diapers. The children were not changed until 10:30am after being in the room all morning.
