Caregivers shall not leave any child without competent adult supervision.

19 CSR 30-62.192 (5)(A)

In case of accident or injury to a child, the provider shall notify the parent(s) immediately. If the child requires emergency medical care, the provider shall follow the parent(s) written instructions.

19 CSR 30-62.112 (1)(B)

Age Two (2) Years. Groups composed solely of two (2)-year olds shall have no less than one (1) adult to eight (8) children, with no more than sixteen (16) children in a group.

CONCLUSION SUMMARY

There was an incident where the classroom was outside. A staff took several of the children inside to use the bathroom. This left the staff outside with more than 8 two years old putting them over ratio. The name to face sheet indicated at 4:00 PM on May 18, 2021 there were 13 two year old and two staff outside. The staff reported she took 2 children inside. This left one staff and 11 two year olds outside which is over ratio. The staff outside lined the children up at about 4:15 PM and came inside. The staff reported they started doing circle time. The staff estimated that between 5-10 minutes later they saw Child A outside through the window. The staff report they did not do the name to face count when they came inside. The incident was not reported to the director until 6:15 PM. The director did not immediately report the incident to the parent. The director failed to report the incident to the parent until about 12 30 PM the next day. The staff left Child A without competent adult supervision, did not maintain ratios inside or when Child A outside unattended and they failed to notify the parent of the incident in a timely manner. Based on the information provided, the allegation is substantiated.
