Walls, ceilings and floors shall be finished with material which can be cleaned easily and shall be free of splinters, cracks and chipping paint. Floor covering shall be in good condition. Lead-free paint shall be used for all painted surfaces.

19 CSR 30-61.085 (2)(A)(7)

Concrete floors in areas counted as child care space shall be covered with carpet, tile, linoleum or other floor covering.

CONCLUSION SUMMARY

The Section for Child Care Regulations determined the family home violated licensing rules on November 20, 2020 based on interviews with the family home owner Diedre Scheulen and observations made by CCFS Ray-Warnke.

CCFS Ray-Warnke observed on November 20, 2020 exposed concrete flooring. Several spots were observed exposed under the family home eating tables and chairs. The owner of the family home Diedre Scheulen stated that the floor was linoleum in 2006. The linoleum started to peel up and was changed to carpet in 2016. The carpet was hard to keep clean and was removed in 2017. The owner Diedre Scheulen stated that she has never had a variance for the concrete floor. Diedre Scheulen stated that the floor does not have a sealant on it. Diedre Scheulen stated that the concrete floor was painted with paint.
