CONCLUSION SUMMARY

Section for Child Care Regulation (SCCR) has determined La Petite Academy, Inc. violated a licensing rule on February 28, 2019, when caregiver Shelby Lewis wrapped Child A in a blanket which prevented him from having free mobility of his body. Interviews were concluded on March 5, 2019. Shelby Lewis admitted she swaddled Child A, and in the process of laying him on his cot, Child A was hit in the eye by his cot. Observations made by CCFS Jill Solomon while viewing video tape of the incident indicate Shelby Lewis did wrap Child A in a blanket in such a manner that his hands and arms were incapacitated, and he was unable to protect his face when his cot flipped up and hit his face. Director Mary Maloid stated in her interview that wrapping a child in such a manner was a violation of the company policy.
